The Exhibitor/Vendor and their individual employees agree to abide by the Terms & Conditions as published by The Fort Myers Beach Chamber of Commerce. The Exhibitor/Vendor acknowledges that a violation thereof may void any contract with the producer. Said Terms & Conditions are incorporated herein by reference and made part hereof.

All booths must be opened and staffed during festival hours. At all times Vendor agrees to operate his/her business and any concession granted hereby in a safety-first and always courteous manner. The Vendor agrees to operate in every respect, in full compliance with all county, local, state and federal law regulations.

The Exhibitor/Vendor understands and agrees that during the course of the event, the Exhibitor/Vendor might appear in photographs, videos, film, recordings and the like in connection with the Exhibitor/Vendors participation in the event. The Exhibitor/Vendor hereby consents to the use of any such audio, photo or video portrayal of the Exhibitor/Vendor or the Exhibitor/Vendor's structure by the Producers for advertising, promotional or any other purposes, and agrees that any such portrayals shall thereafter become the sole possession of the producers for their use thereafter. Exhibitor/Vendor further agrees to comply with any reasonable request of the Producer for the Exhibitor/Vendor to assist in the public relations activity of the Event.

Event Date and Times: The 26th Annual Taste of the Beach will be held on **Sunday May 1, 2022 from 11:00 a.m. – 4:00 p.m**.

Chamber Membership: Exhibitors/Vendors and Restaurant Vendors do not need to be members to participate. For information on membership please call 239-454-7500.

Approved Items for Sale. All items sold in each booth must be approved. Only items/product type listed on the application and approved by Event Management may be sold at the Event.

Booth Space: Each booth space is 10X10. Each exhibitor/vendor is responsible for bringing their own tent, tables, chairs, fire extinguisher or anything else they need for the event. No tent rentals will be available for the event.

Electric: There will be <u>no electric for exhibitors/vendors</u>. You are **not** permitted to use portable generators on site.

Insurance: All Vendors must supply a copy of their liability insurance in the

minimum amount of \$1,000,000 naming The Fort Myers Beach Chamber of Commerce and Big Game Hunters dba Original Shrimp Dock Bar & Grill as additional insured. Please have your agent submit a copy of the current insurance for our records with your application, or forward such to the chamber main office prior to **1pm, Friday April 23rd, 2022**. Applicants without insurance may not participate in the event and will not receive a refund.

Commitment to Paying Taxes: The Exhibitor/Vendor agrees to pay all necessary local, state, and federal taxes from earnings at the Taste of the Beach Festival. The exhibitor/vendor agrees to comply with all tax regulations, including timely payments. The Exhibitor/Vendor also agrees to not hold the Fort Myers Beach Chamber of Commerce liable for any local, state and federal taxes from income that is earned at Taste of the Beach.

Cancellations: Cancellations will be honored if received in writing 30-days in advance of event date. Cancellation by phone or no-show will not be refundable.

Rain Date / Weather: This is a rain or shine event.

Fire Extinguishers: All Exhibitor/Vendors must supply a fully charged and date tagged 5 pound multi-purpose dry chemical fire extinguisher at each booth. The Fire inspector will be checking periodically. Please have your extinguisher present at all times.

Drinking and Smoking: Consumption of Alcohol and or use of illegal substances by participants during the event are prohibited.

Setup: Exhibitor/Vendor setup will take place Sunday May 1, 2021; you will be permitted access at **7:30 a.m**. Setup must be completed by **9:30 a.m**., and the area must be cleared of all vehicles. Parking is available for vendors off site.

Participants are required to remain open and staffed until 4pm. No one is permitted to breakdown and/ or leave until after the event has concluded. Vehicles will not be permitted into the festival area until all guests have been cleared from the festival grounds. In signing this, you agree to abide by all the Terms & Conditions outlined in this Fort Myers Beach Chamber of Commerce Taste of the Beach Terms & Conditions form.
